## **Employment**

- Employee of the Golden Women's Resource Centre (GWRC)
- Year-round, part time position 13 hours per week.
- Flexible schedule
- Wage is equivalent to CSSEA Wage Grid 16p starting at \$43/hour
- Based out of Downtown Golden BC
- This position is part of the Sexual Assault Services program which is funded by the Ministry of Public Safety & Solicitor General.

#### **Job Responsibilities**

- Assessment & Planning. Develop and implement short-term counselling plans for the client by assessing client's needs and goals.
- Individual Counselling. Provide sessions of individual clinical counselling to each client.
- Information and Referrals. Provide resources and referrals necessary to meet client needs.
- Tracking and Reporting. Maintain complete and confidential records and provide reports as required.
- Other tasks as reasonably required for the operation of the Golden Women's Resource Centre.
- Group Counselling. Depending on demand, the SAS Program Counsellor may provide group counselling or workshops for clients.
- Participate as part of a team and work with others towards fulfillment of program and organizational objectives.

### Qualifications

- Eligible for a registered membership with one of the following professional associations:

  - o BC Association of Clinical Counsellors
  - BC Psychological Association
- Experience or training in:
  - Counselling survivors of Sexual Assault

- The successful candidate will be required to provide a clear criminal record check for working with vulnerable adults and children.
